Pension application of Morris (Morice) Fennel (Fennell) W7257 Penelope Fennel f25NC Transcribed by Will Graves 12/19/08 rev'd 1/28/15

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of North Carolina Sampson County

On the 20th day of August 1823 personally appeared in open Court being the County Court of the County of Sampson aforesaid & the same being a Court of Record Morris Fennell aged 67 years who first being duly sworn according to law doth on his oath make the following declaration in order to obtain the provisions made by the acts of Congress of the 18th of March 1818 & the 1st of May 1820 that he the said Morris Fennell enlisted for the term of nine months on the 15th day of May 1778 in the State of North Carolina in the Company commanded by Captain Thomas White in the Regiment commanded by Colonel James Armstrong in the Line of the State of North Carolina Continental Establishment that he continued to serve in the said Corps until the 5th of August 1779 -- when he was discharged from the said service at Stone River [Stono] in the State of South Carolina & that he has no other evidence now in his power except William Lord & in pursuance of the act of the first of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or otherwise disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed



State of North Carolina Cumberland County

This day personally appeared before me one of the Justices of Peace in of and for the County of Cumberland and State aforesaid: Captain William Lord of the County of Cumberland & State aforesaid. After being duly sworn according to law deposeth & saith that he the deponent is personally acquainted with Maurice Fennell [sic] of Sampson County & State of North Carolina the present claimant for Pension and this deponent further saith that he deponent was personally acquainted with the said Maurice Fennell in the year 1778 as well as deponent recollects and that the said Maurice Fennell & this deponent met at Elizabeth Town in Bladen County North Carolina in December 1778, and marched with the Continental troops from thence to Purrysburg South Carolina at which place the said Maurice Fennell was attached to Captain Thomas White's Company in which this deponent was a Lieutenant of the Continental Army U.S. and under whom the said Maurice Fennell did Served as a Sergeant in said Captain White's Company and was in the Battle of Stono [June 20, 1779] South Carolina and faithfully performed his duty while a Soldier in the said Continental service and the said Maurice Fennell did continue in said Continental Service as aforesaid nine months at one continued time and was honorably discharged After the expiration of the nine months Further this deponent saith not. Sworn & subscribed before me at said born the 6th day of May 1820 and to whose affidavit do you faith & credit is attached.



[p 10: On November 21, 1853, in Sampson County, NC, Penelope Fennell, 69 on January 3 next, resident of Duplin County, NC, filed for a widow's pension as the widow of Morris alias Maurice Fennell; she states that she married him December 8, 1818; that he died February 29, 1828 in Sampson County North Carolina; that she remains his widow; that they were married in the house of John Hufham in Duplin County; that there was only one child born of her marriage to Morris Fennell, Leonora, the wife of John H. Heath.
