Pension application of Hugh Forsyth W7315 Nancy Forsyth f40NC Transcribed by Will Graves 1/4/09 rev'd 6/12/15

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

[p 5] State of North Carolina Mecklenburg County: Court of Pleas and Quarter Sessions October Term 1853

On this 27th day of October A.D. 1853 personally appeared in open Court, before the Justices of the County Court John Forsythe a resident of said County aged sixty-nine years, who being first duly sworn according to law, doth on his oath make the following declaration, in order to obtain the benefit of the provisions made by the Acts of Congress passed June 7th 1832, July 4th 1836 – July 7th 1838 and all previous & subsequent Acts of Congress applicable to his case -

That he is the son of Hugh Forsyth who was a soldier of the Revolutionary war and served his country faithfully for several years but under what officers he served, or what battles he was in, this deponent does not know, he cannot say further than that his said Father has often talked to him about his services, and suffering in said war, but deponent can give no intelligible account of it, he being a very illiterate man and rather weak in mind; but that his Father did serve he has no doubt and relies for proof of his services upon the Revolutionary muster rolls of North and South Carolina; and of his identity, upon traditionary history and the affidavits herewith presented, deponent has no documentary or record evidence in support of his Claim, and therefore relies for proof upon the public records of the Country, and upon the affidavits of identity from persons of credibility -- which deponent prays may be liberally constructed.

He further declares that his Father the said Hugh Forsyth died in or about the year 1828, leaving a widow who died the 14th of June 1838 -- leaving surviving her Hugh, Jane, Margaret, & John Forsyth, all of whom are now dead as this deponent believes that himself who is the only surviving heir -- deponent further states that his Father was married during the Revolution to Nancy Lawson, by which said marriage he had the above named children. That deponent's Father left no record of his marriage. That deponent's Father and mother lived together as man and wife until the death of his Father, that his said mother remained a widow until her death all of which will more fully appear by reference to the proof hereunto appended. Sworn to and subscribed in open Court before.

Then came Joseph Stewart before us John McCorkel & William Mathews two of the Justices of the peace for said County and made oath that Hough Forsith [sic] was a Soldier in the Continental line of this State for nine months, and that he actually served the term of nine months under Colonel Arch'l Lightle [Archibald Lytle] (Colonel of the Continental line of this State) in the aforesaid line and that he did not desert. Given under our hands and seals on this 10th day of July 1792

This day Hugh Forsyth personally appeared before us Adam Alexander & John Foard two of the Justices for said County and made oath that he Served as a Soldier in the Continental service for 9 months and was lawfully Discharged and that he never Received any Part of the final Certificate or the Depreciation of the pay due him for the said services nor any other Ways Otherwise and Person or persons to Draw the same Except the above named George Camble Sworn to before us this 9th Day of May 1792.

State of North Carolina Comptroller's Office I William & Clarke, Comptroller of fublic account; in and for the State aforesaid do hereby certify that it appears of record in my office, among the payments made by said state to sundry persons for Melitary services in the Revolutionary War, as follows, to wit: Hugh Forsyth Bundle endorsed army claims settled at Hillsboro in 1792". Hugh Forsyth, private soldier, exhibited his account against the United State, to the Commissioners of army accounts as follows: 1778 To 13 months pay at 63 dollars \$ 11. 11 1779 To 7's months pay at 63 dollars 118.85 The rest of the account contains charges of Interest and Credits of payments made to said Hugh Forsyth and The balance due on final suttement was paid to George Campbell, attorney for said Foryth who duly recepted The papers, discharge to hereunts anneyed were taken by me from the file and marked with my initials (W.J. b) in red ink In testimony whereof I have hereunts subscribed my name and affixed my seal of office this 22d. day of March Word black Compt.

[Veteran's widow's heirs were awarded the pension due her at the rate of \$30 per annum based on her husband's service as a private in the North Carolina Continental line.]
