Pension application of James McCracken W7416 Transcribed by Will Graves Mary McCracken f36SC 3/11/09: rev'd 9/20/16

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention.]

State of Tennessee Lawrence County: Circuit Court February Term 1845
Be it remembered that this day the following affidavits & declaration were presented in open Court, & ordered to be placed upon the minutes of the court, to wit: -- State of Tennessee, Lawrence County: SS

On this third day of June 1844, personally appeared before me William W. Evans a justice of the peace in and for said County, Mary McCracken a resident of said County & State aged 85 years, who being first duly sworn according to law, doth, on her oath, make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed July 4th 1836, & the act explanatory of said act, passed March 3rd 1837: That she was married to James McCracken on or about the 22nd day of January 1779, that her said husband was a private in the war of the Revolution, & served under Col. Thomas Brandon (or Branon, as pronounced) of South Carolina: Said James served against the Cherokee Indians, & also marched southward against the Florida Indians, in the expedition under St. Clair, & also in the snow camps, so called, in South Carolina. She further declares, on her oath aforesaid, that her said husband died on or about 8th day of August 1824, & that she is now & has remained, a widow ever since that period, as will more fully appear by reference to the proof hereto annexed (signed)

"Mary McCracken, X her mark"

Sworn to & subscribed before me the 3rd of June 1844 S/W. W. Evans, JP [p 9]

Then came John McCracken who being first duly sworn, according to law, deposeth and saith, that he is the eldest child of James & Mary McCracken, mentioned in the foregoing declaration, & that he was 65 years of age on the 18th day of November last, & that he well remembers to have heard his late father frequently state that he had served through the war of the Revolution as a volunteer; that he was at a battle at Blackstock's Mills [November 20, 1780]<sup>1</sup> (in what is now called Union District), in South Carolina: he said he served under Col. Brandon (sometimes pronounced Branon); also in the Cherokee & Florida expeditions. This affiant remembers his late father often talked of the scarcity of provisions in the Florida expedition, & of the hardship & little effect produced by said Florida expedition. This affiant states that he has read the

foregoing declaration of his mother & believes the same to be true: & further this deponent saith that said declaration was made & sworn to before William W. Evans, on the day it bears date, who was then an acting Justice of the said County, but that he has since died.

State of Tennessee Lawrence County

Personally appeared before me A. S. Alexander chairman of the County Court of said County, Thomas Davis<sup>3</sup> aged eighty-three or eighty-four years, & being first duly sworn deposeth & saith that he was a soldier in the revolution of 1776, for five years, for which services he now draws a pension. Deponent says he was well acquainted with James McCracken of Union District South Carolina, having served with him in the Cherokee expedition under Col. Brandon, Lieut. Col. Steen & Capt. James Grant & Lieut. Joseph Hayes. Affiant also remembers to have seen said James in the service of the United States at Charleston South Carolina, Savannah, Georgia, at Ninety Six & other places whose names by reason of his great age & infirmities he has forgotten, but knows that the said McCracken was a soldier of the Revolution & that with him in camps during five or six years. This affiant does not know the precise age of said McCracken but knows he was three or four years, perhaps more, older than himself --. And further this deponent saith not.

[p 18: Certificate dated November 10<sup>th</sup>, 1846 issued by the South Carolina Comptroller General showing payments made to James McCracken a private in Martin's troop of Polk's Regiment Sumter's Brigade for £94 for services in that troop; also payment of £4 for 72 days militia service in 1782; and finally 20 pounds 14 shillings and 3 ¼ pence for duty served in Brandon's Regiment of unspecified length.]
