The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of North Carolina, Mecklenburg County: Superior Court of Law Fall Term 1832

On this 12<sup>th</sup> day of November A.D. 1832 personally appeared in open Court Before the Court now sitting Samuel Givens of the State and County aforesaid aged 70 years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the Benefit of the act of Congress passed June 7<sup>th</sup>, 1832 that he Entered the Service of the United States under the following named officers & served as herein Stated he entered the Service in the year 1780 as a volunteer in the summer of the same year and served under Captain John Harris a tour of two months and in the fall of the same year he volunteered under Captain John Foster and served a tour of six weeks and then in the spring of 1781 he enlisted under Captain John Foster and joined Colonel Henry Hamton [sic, Henry Hampton's] Regiment and then was Transferred to Colonel Wade Hamton's [Wade Hampton's Regiment under Captain Barnett. General Sumter [Thomas Sumter] Commanded and served a Tour of ten months and was discharged on the 13<sup>th</sup> of February 1782 as will appear from the discharge which is herein enclosed and served as near as he can recollect thirteen months and two weeks and was in the Battle of the Eutaws [sic, Eutaw Springs, September 8, 1781] and traveled through South Carolina and into the State of Georgia he has no Record of his age But believes he was born in the year 1762 in the County of Mecklenburg State of North Carolina here he lived when he was called into service and has been there ever since the Revolutionary war he hereby Relinquishes every Claim whatever to a pension or annuity except the present and declares that his name is not on the pension Roll of the agency of any State.

State of North Carolina, Mecklenburg County

On this 5<sup>th</sup> day of April 1834 personally appeared before me John M. Ingram one of the acting Justices of the Peace in and for the said County Samuel Givens a Resident of said County aged 71 or 72 years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed 7<sup>th</sup> of June 1832. That he entered the service of the United States under the following named officers and served as herein after stated.

He entered the Service of the United States as a volunteer 1<sup>st</sup> of September 1780 under Captain Benjamin Lowery and served a Tour of two months part of the time under Captain B. Lowery of two or three weeks and the balance of the time under Captain John Harris in Mecklenburg and Started from Mcorpins [sic, McAlpine?] Creek and marched to the Waxhaw Creek and was in the Scrimmage at Walkups Mills [Battle of Wahab's Plantation, September 21, 1780]<sup>3</sup> and then Retreated back as far as Salisbury N. C. there was stationed a few days (we were at this time under the command of Colonel Davey [sic, William Richardson Davie] and General Davidson [William Lee Davidson]) and then we marched Back as far as Rocky River and there we stopped a few days until news reached us that Cornwallis had left Charlotte then we marched through Charlotte on to Lancaster District S. C. and was discharged 1<sup>st</sup> of November 1780 by Captain John Harris and in December 1780 he volunteered under Captain John Foster and served a Tour of six weeks and went from Mecklenburg County NC to Richardson's Creek and Lynches Creek in South Carolina and our Lieutenant John Houston was killed in that Tour at Lynches Creek and then we Returned Back to Mecklenburg and was discharged in January 1781 by Captain Foster and on 13<sup>th</sup> of April 1781 he enlisted under Captain John Foster in Colonel Henry Hampton's Regiment number not Recollected and afterwards transferred to Colonel Wade Harris [sic, Wade Hampton's?] Regiment General Sumter Commanded and served a Tour of Ten months under Captain Jacob Barnett and in that Tour, he went from Mecklenburg County NC through SC to the Congaree [River] and was stationed there for some time at a place called Brown's old fields and then marched to Orangeburg and was stationed there a while and from Orangeburg (But before we marched to Orangeburg we marched under Captain Barnett in Colonel Wade Hampton's Regiment own down Santee River and fought at the Battle of the Eutaw [Eutaw Springs] on 8 September 1781) marched in to the State of Georgia and was stationed at Spirit Creek Mills a while and the Balance of the time we were in Georgia we was kept traveling about which was about two months and then we Returned Back to Orangeburg and there was discharged near Orangeburg in SC by a man whose name I cannot recollect on the 13<sup>th</sup> day of February 1782 and served in all thirteen months and two weeks and has no documentary Evidence of his Service the remains of his discharge from the ten months service which was sent in the original declaration which you examined and returned as so much [indecipherable word, looks like "defast" may have been intended to be "defaced"] as not to be properly understood is destroyed and he hereby Relinquishes every Claim whatever to a pension or annuity except the present and he declares his name is not on the pension Roll of the agency of any State. Sworn to and Subscribed the 5<sup>th</sup> day of April 1834 Before me.

[p 4: On July 7, 1853 in Union County North Carolina, Lucinda Givens, 57, filed for a widow's pension under the 1853 act stating that she is the widow of Samuel Givens, a revolutionary war pensioner at the rate of \$44.88 per annum; that she married him May 18, 1836; that they were married by John Blount Esquire; that her husband died April 15, 1846; and that she remains his widow.

[p 5: On July 7, 1853 in Union County North Carolina, William B Cook and John Blount gave testimony that Lucinda Givens the widow of Samuel Givens was married to him on May 18, 1836 by John Blount Esquire, at M. D. Paxten's house in Mecklenburg County (now Union) North Carolina.]

[p 5: John Blount gave testimony that he is an acting justice of the peace for Mecklenburg County; that in the year 1836 he solemnized the rights of marriage between Samuel Givens and Lucinda Cook, now Lucinda Givens, widow of Samuel Givens.]

[Veteran was pensioned at the rate of \$44.88 per annum commencing March 4<sup>th</sup>, 1831, for service as a private for 13 months and 14 days in the North Carolina militia. His widow was pensioned in a like amount.]
