Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

I Duncan McLaurin one of the acting Justices of the Peace in and for the said County do hereby certify that I have cut the annexed leaves out of an old Hymnbook handed to me by Hector McNeill which I believe formerly was the property of Lauchlin McNeill and that record on said leaf is the family record. I further believe that the said Lauchlin & Mary McNeill never had but the one son and that his name is recorded in said leaf given under my hand &c. this the 6th day of October A.D. 1852.



On this 6<sup>th</sup> day of October 1852 personally appeared before me an acting Justice of the peace in & for said County Mr. Hector McNeill resident of said County who being duly sworn according to law doth on his oath make the following declaration, To obtain the benefit of the provision of the Act of Congress of 7 of June 1838 & subsequent acts above mentioned, that he

is the son of Lauchlin McNeill who was a soldier of the Revolutionary war that his father the said that Lauchlin McNeill served as a private in militia under Capt. Archibald Smith, Capt. Williams, Capt. Shipman [Daniel Shipman], Capt. Ard [Thomas Ard], Col. Regan, General Lee & others, that the said Lauchlin McNeill was in the Battle of Hillsboro the Battle of Canes Creek that he remained in the service two or more years as he has reason to believe that the said Lauchlin McNeill was married on the 10 day of August 1790 to Mary McNeill the mother of this declarant in the County of Robeson & State aforesaid that Mrs. McNeill's maiden name was Mary McNeill that the said Lauchlin McNeill died on the 31st day of August 1838 aged about 80 years that Mary McNeill his widow the mother of this declarant died on the 22nd day of May 1852 aged 80 years that the said Lauchlin McNeill never made application for a pension because he was not aware that any laws were passed in favor of Revolutionary Soldiers that his mother the said Mary McNeill did not know she was entitled to a pension until a short time before her death. He therefore makes this application for the amount due his father the said Lauchlin McNeill up to the time of his death & of his Mother Mary McNeill up to the time of her death on account of the Revolutionary Service of his father the said Lauchlin McNeill.
