[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

[p 5] State of Ohio, Preble County

On this twenty first day of September in the year of our Lord 1832 personally appeared in open Court before the Honorable the Judges of the Court of Common Pleas in and for the County of Preble and State of Ohio now sitting William Gray a resident of Dickson Township Preble County and State of Ohio aged Seventy Six years who being first duly sworn according to law doth on his Oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7th 1832. That he entered the Service of the United States in the North Carolina Militia in the latter part of the summer or fall of 1778 in the County of Randolph in the State of North Carolina (where he then resided) as Captain of a Company of mounted men (or Horse) and that he continued in the service and held and exercised the rank and command of Captain of said Company or troop of Horse for about three years and until the close of the Revolutionary War, & that during said time he found & furnished his own horse and equipage. And that said company was regularly organized and subject to the same rules, laws & regulations of the militia of said State, and was attached to and composed a part of the Randolph Regiment of North Carolina Militia which Regiment was then commanded by Colonel John Colyer [sic, John Collier] and after him by Col. James Duggans [Lt. Col. James Dougan also spelled James Dugan]. And that General Butler [John Butler] commanded the division of Militia to which he was attached. That the military operations of their Regiment during his Service was mostly confined to the State of North Carolina, that they were attached to no body of Regular troops but were always kept in motion marching rapidly from one point to another protecting the Inhabitants from the British soldiers and the Tories, had some severe fighting was in what was called the Needam [sic, Needham?] action near Deep River on the 8th of June he thinks in 1781 Colonels Lofton & Colver was in the action. That previous to his entering the service he was legally elected Captain of the company which he afterwards commanded, that after his election he received a Brevet commission as Captain signed by General Butler who commanded the Division of Militia to which he belonged, on which he was sworn into office, he does not recollect the date of said Brevet, and has by accident long since lost it. But he continued to serve under it as aforesaid until shortly before he left the service, when he received a commission regularly made out and signed by Alexander Martin then Governor of North Carolina and I. Glasgow Secretary dated 25th of January 1782 which commission he now has & exhibits it to the court, about the time or shortly after he entered the Service Governor Burk [sic, Thomas Burke] then Governor of that State was taken prisoner by the British [September 12, 1781]² and was retained for some time and after his release he resigned. This circumstance he assigns as the most probable cause

why a regular commission was not sooner made out for him. But he avers & declares that he did serve as aforesaid and that during the time he remained in the Service he held and exercised the rank and command of Captain of said company in the Militia of North Carolina – he cannot state the precise time he left the Service but is certain and positive that he remained in the Service until the close of the War – and his Country no longer needed his Services, he has no hesitation in saying that he Served in the Capacity aforesaid something upwards of three years and that he found & furnished his own horse & equipage during said time he further states that he has no documentary evidence of his said service except his said commission. He hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension Roll of the agency of any State, he further states that he has no record of his age, But believes he was Born in September 1756 in the County of Lancaster and State of Pennsylvania and that he lived in Randolph County and State of North Carolina when called into Service and Served in the militia of that State and since the Revolutionary war he resided in Blount County in the State of Tennessee and from that place he came to Preble County in the State of Ohio where he now resides and has resided for sixteen years last past. And that he is known to and acquainted with Robert Rhea, John Truax and others in his present neighborhood who can testify as to his character for veracity and their belief of his Services as a soldier of the Revolution.

State of Indiana Wayne County: To Witt [sic]

Personally appeared before me George Springer a Justice of the Peace within and for said County John Dugan³ of the County and State aforesaid who being of lawful age and after being duly Sworn by me the said George Springer deposeth and Saith, that, William Gray of the County of Prebble [Preble] and State of Ohio Served as a Captain of a Company of Horse in the Revolutionary War, and that I Served as a private under his command and further that during the term of 2 years and upwards said Gray commanded a Company of horse in the State of North Carolina, and found his own horse and accoutrements of War, during the above described term, and further said Gray was under the Command of General Butler of North Carolina, and as far as I know rendered General Satisfaction to his Superior Officers, and further this deponent sayeth not.

of Preble, William Gray who has Subscribed and Sworn to the foregoing declaration and being by me duly Sworn according to law deposeth and saith that by reason of old age and the consequent loss of memory he cannot Swear positively as to the precise length of his Service but according to the best of his recollection, his served in the capacity of Captain of a volunteer company of Horse and the Randolph Regiment of North Carolina militia as stated in the foregoing declaration not less than three years and six months which Service was rendered during the War of the Revolution and for such Service he now claims a pension.

State of Ohio, Preble County: 1st Judicial Circuit of the Court of Common Pleas and the State of Ohio March Term 1833

On this 23rd day of March 1833 personally appeared in open Court before the Honorable Judges of the Court of Common Pleas now sitting John Duggins [sic, John Dougan] aged 70 years who being duly sworn according to law Deposeth and Saith that he is now and has been personally acquainted with William Gray now of Preble County Ohio for near 60 years and that some time in the latter part of the summer of 1778 he entered the service of the United States as a volunteer in a company of volunteer mounted man or Horse in Randolph County in the State of North Carolina in the Randolph Regiment of North Carolina Militia that he continued in the service until the Spring of 1782 and that the said William Gray entered said service at the same time and place and held and exercised the rank and command of Captain of said company and that when this Deponent left the Service he left said Gray in the Service and this Deponent further states that he knows from his own personal knowledge that the said William Gray did Serve as Captain of said Company for at least three years and that this Deponent served as a private in said Company under said Gray and that said Gray as well as the other members of said company furnished his own horse that he knows said Gray personally and has known him ever cents they were small boys and he knows said Gray to be the same person who has signed & sworn to a declaration in order to obtain the benefit of the act of Congress passed 7th June 1832 – dated 21 September 1832.

And also at the same time and place came personally John Runyon⁴ aged 70 years who being duly Sworn according to law deposeth and saith that in the summer of 1781 he was in the Service of the United States in the Randolph Regiment of North Carolina, that he was then and now is personally acquainted with William Gray now of Preble County of Ohio and that he then seen said William Gray in the service and that said Gray had had the command of a company of Mounted men or Horse, and said Gray and this deponent were both in the Needham Battle at Deep River which was fought the 8th of June 1781, he this Deponent saw said Gray in the action and knows that he was Captain of a

company of Horse men. Deponent does not know how long said Gray was in the service and knows he remained in the service till the end of the War & held the command of Captain as aforesaid.

[p 12: On May 24, 1851 in Preble County Ann Gray aged 86 filed for a widow's pension stating that she was the widow of William Gray, a pensioner of the United States at the rate of \$300 per annum which terminated on March 8, 1849. She signed this document with her mark.]

[p 16: On May 24, 1851 in Preble County John Gray, aged 54, gave an affidavit stating that he was the son of William and Ann Gray, that his parents were married in 1786, that he is his parents fifth child and was born on June 15, 1797, that he has two brothers and two sisters older than himself, Robert, Sarah, Thomas and Jane, that his brother Thomas his mother's third child served two tours in the War of 1812, that his father William Gray died March 8, 1849 and that his mother is still living and still a widow.

[[Veteran was initially pensioned at the rate of \$300 per annum commencing March 4th, 1831, for service as a Captain for 2 years in the North Carolina militia. The pension was subsequently increased to \$600 per annum and paid from March 4th, 1831 to March 8, 1849. His widow received a pension in a like amount.]
