Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

For the purpose of obtaining the benefit of the act of Congress for the relief of certain Surviving officers and soldiers of the Army of the Revolution approved on the 15th of May 1828. I George Humphries aged Sixty-four years of the County of Gibson in the State of Indiana do hereby declare that I enlisted in the Continental line of the Army of the Revolution in the fall of 1781 in a company of Light Dragoons at or near the Town of Williamsburg Virginia for and during the War and continued in its service until its termination at which time I was a private in Captain Hughes [perhaps John Hughes] Company or troop of Light Dragoons in the first Regiment commanded by Colonel White [Anthony Walton White] in the Continental line and previous thereto he served in the eighteen months service in the foot and I also declare that I afterwards was discharged at Richmond Virginia, and received a certificate or some papers the contents of which I do not now clearly recollect, I believe I afterwards sold some of them at a discount and I am of the impression some of those papers then received was the certificate for the money I was entitled to under the resolve of Congress mentioned in the 2 by the late act of Congress in the instructions of the Secretary of the Treasury, but to say certain I cannot. I hereby certify or declare that I was not on the 15th day of March 1828 on the pension list of the United States.

Bounty Lands for Revolutionary Services – Individual Application State of Indiana County of Gibson: SS

I, George Humphries aged Sixty-four years, do upon oath testify and declare that about or in the year 1781 I enlisted or entered the service as a private for the term of "during the war" in the Dragoon Regiment commanded by Colonel White and afterwards served in the aforesaid

Regiment under the command of Colonel White and that I continued in service aforesaid until the close of the war, when I was regularly discharge from the aforesaid Regiment commanded by Colonel White of the Virginia line, and when I was a private I received a discharge after, or at the close of the War which is lost or mislaid, long since the manner which I lost it I am not able at this time to state.

I further declare, that I have never received a warrant for the Bounty Land promised to me on the part of the United States; nor have I ever assigned or transferred my claim in any manner whatsoever:

[p 17: On June 20, 1853 in Edward County Illinois, Mary Hull, 47 [?]³, made application for a widow's pension under the 1853 act as the widow of George Humphreys, a revolutionary war pensioner; that she married him February 25, 1838; that he died April 10, 1840; that she married Felix Hull on December 19, 1843 and that Felix Hull her 2nd husband died in 1850. She signed her application with her mark.]

[Facts in file: The veteran married in Clay County Illinois February 25, 1838, Mary Rose; the widow was still living in 1877 when she resided in Farmersviller, Tulare County, California

[Veteran's widow was pensioned at the rate of \$100 per annum commencing March 3rd, 1853 for her husband service as a private in the Virginia Continental Cavalry.

To His Excellency the Governor of the State of Virginia

The Memorial of George Humphreys [sic] of the state of Illinois and formerly of the State of Indiana humbly represents

That your petitioner was born in Northumberland County State of Virginia in the year 1764 that in the spring of the year 1781 he filled the place of John Tillison (who had been drawn or drafted from the County of Prince William) as a substitute and was mustered by Colonel Lee [Henry "Light Horse Harry" Lee] of Prince William County in the service of the State of Virginia, that he was placed under the command of one John Tibbs and was marched by him from the Humphreys to Alexandria on the Potomac and Fredericksburg on the River Rappahannock, that when General Lafayette came through Fredericksburg with his Army the detachment to which your petitioner was attached was ordered and marched in the rear of General Lafayette's Army, still commanded by the said Tibbs and from thence to Bottoms Bridge where your petitioner understood the militia lay and from thence by the way of Westham on
