Pension application of Thomas Hawks (Hawkes) W7658 Margaret Hawks f37VA

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later intereenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Virginia Dinwiddie County Sct.

On this 17th day of September 1832 personally appeared before the County Court of Dinwiddie in the State aforesaid Thomas Hawks, a resident of Dinwiddie County, aged Eighty years the 5th day of May last, who being first duly sworn according to law doth on his Oath make the following declaration in order to obtain the benefits of the provision made by the Act of Congress passed June 7th 1832.

That he entered the service of the United States as a Militia Soldier, under the following named Officers, and served the following towers [tours] of duty, in the year 1778 and 1779.

The first tower was under Captain Armistead Goodwyn & others (two months), the second tower under Captain John Nicholas & others (two months), the third tower in Brunswick County under Colonel Richard Elliott, Major Thomas Edmonds, Captain Lawrence House & others (two months), the fourth tower under Captain William Eppes & others (two months) making altogether eight months.

That in the year 1781 he joined the United States Army under Colonel Charles Dabney, Captain Gibbs, Lieutenant Wood & Ensign Slaughter and marched to Little York and joined the Army under General George Washington, after the taking of York and the Army under Cornwallis [October 19, 1781], he was marched to Richmond as a guard to the prisoners, and discharged in March 1782 in this tower he served upwards of 6 months. That after he retired from the service he gave his discharge [to] Captain John Conway to enable him to get his pay for his services, who never returned it [to] him.

He hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension roll of the agency of any State whatever.

[p 9: On March 28, 1843 in Dinwiddie County Virginia, Margaret Hawkes, 92, filed for a widow's pension under the 1838 act stating that she is the widow of Thomas Hawks, a revolutionary war pensioner; that she married him in the County of Dinwiddie about the month of December 1785; that they were married by Parson Harrison; and that her husband died in Dinwiddie County June 6, 1835. She signed her application with her mark.]

[p 27: On June 20th, 1843 in Dinwiddie County Virginia, Elizabeth McCullock gave testimony that she was well acquainted with Margaret Hawkes and was present at the wedding of Thomas Hawks to Margaret in Dinwiddie County at a place then called the "Globe" Tavern and now called "6 mile house"; that from the ages of the affiant's children, the affiant being married after the veteran and his wife were married, the affiant is of the opinion that they must of been married prior to the year 1790.]

[Veteran was pensioned at the rate of \$46.66 per annum commencing March 4th, 1831, for service as a private for 14 months in the Virginia service. His widow was pensioned at the rate of \$36.66 per annum]
