Pension application of Laban Hawkins ¹ W7659 Catharine Hawkins f19VA rev'd 1/11/09 & 6/11/11 & 3/24/12 & 6/8/15

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Declaration In order to obtain the benefit of the Act of Congress of the 7th July, 1838, entitled "An Act granting half pay and pensions to certain widows--"

State of Virginia, Halifax County, to wit:

On this 31st day of January, 1839, personally appeared before me a Justice of the Peace in and for the County and State aforesaid Catherine Hawkins, a resident of said County and State, aged 68 years, who being first duly sworn according to law, doth on her oath, make the following declaration in order to obtain the benefit of the provision made by the Act of Congress, passed July 7th 1838, entitled "An Act granting half pay and pensions to certain Widows---"

That she is the widow of Laban Hawkins late of the said County and State, who was a Private in the Continental line and militia service of the State of Virginia, in the war of the Revolution. She declares that she does not know any thing as coming within her personal knowledge, respecting the services of her late husband in the Revolutionary War, excepting what she has repeatedly heard from him in his life time and from others who served with him at the time. She recollects distinctly hearing him say, that he was a long time in the service, was engaged in several battles, and suffered many hardships and privations during the time. That in consequence of old age, and loss of memory she cannot at this time call to mind the particulars of his service, and therefore prefer to rely on the statement of old soldiers who served with him, whose affidavits accompany this her declaration. She further states, that for the same reason, she cannot say how long he was in actual service altogether, but supposes that at the smallest estimate, he must have been in service altogether for the period of 24 months--for which time she claims a pension. In support of her claim, she relies on the Public Records, and accompanying certificates of old soldiers. She further declares that her husband died before the passage of the Act of Congress of the 7th June 1832, or he would have been entitled under that act.

She further declares that she was married to the said Laban Hawkins, on the 30th day of December, 1784; that her husband, the aforesaid Laban Hawkins, died on the 18th day of May, 1820: that she was not married to him prior to his leaving the service, but the marriage took place previous to the first day of January, seventeen hundred and ninety four: to wit, at the time above stated.

I further certify, that she is a credible person, and her statement entitled to full confidence.



This is to Certify, That it appears from a List in this Office of such Officers and Soldiers of the Virginia Continental Line, during the Revolutionary War, as settled their Accounts, and received Certificates for the balance of their Full Pay, according to an Act of Assembly, passed the November Session 1781, that a Certificate issued on the 14th day of April 1785, in the name of Laban Hawkins, as a Soldier of Infantry for £35.11.6, which Certificate appears to have been delivered to Mr. Chaffin Shipp [?] and was given for services prior to the 1st January 1782.

To his Excellency the Governor of the Commonwealth of Virginia:

The Memorial of the Heirs and legal representatives of Laban Hawkins, deceased, late of Halifax County, Virginia, who was a soldier of the State line of Virginia on Continental establishment in the War of the Revolution: Respectfully Sheweth:

That the said Laban Hawkins in the year 1777 in the County of Amelia enlisted as a soldier under Captain Hoard for the term of three years and was attached to the command of Colonel Buford in the South – He was taken prisoner at Buford's defeat – That after being exchanged, and serving the full period of his enlistment, he was honorably discharged from service all of which, will more readily appear by reference to the Army Register of the Continental line, and the accompanying certificates of those who served with him –

Your memorialist further states, that the said Laban Hawkins, in his lifetime, did not apply for, or obtained the land bounty provided by the State of Virginia to her officers and soldiers of the Continental line; nor have the heirs since the death of said Laban Hawkins –

Your Memorialist therefore humbly pray, that your Excellency will grant them the usual [several lines not copied and displayed on the digital image] tal line for the service of 3 years, pursuant to the laws of Virginia in such case made and provided – And as in duty bound, shall ever pray &c
