[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

State of Tennessee Grainger County: On this 2nd day of July 1847 Personally appeared before me John Ivy a Justice of the peace in and for the County aforesaid Jane Howell a resident of Grainger County aged eighty-one years who being first duly sworn according to law doth on her oath make the following Declaration in order to obtain the benefit of the provision made by the Act of Congress passed July 7th 1838 entitled an act granting half pay and pensions to certain Widows. That she is the widow of Henry Howell who was a soldier of the Revolution and served as herein after stated (viz.) He served 3 or 4 tours in the militia of North Carolina she cannot tell the names of his Officers or give a detailed of his service but depends on the proof of the Comptroller of Public Accounts of North Carolina to sustain her claim. She further declares that she was married to the said Henry Howell on the 11th day of July in the year 1784. That her husband the aforesaid Henry Howell died on the 4th day of October as 1819. That she was not married to him prior to his leaving the service but the marriage took place previous to the first day of January 1794.

State of Tennessee Grainger County: SS

Personally appeared before me John Ivy an acting Justice of the Peace in and for said County Jane Ivy a resident of said County and makes oath that Henry Howell whose widow has filed the foregoing declaration was her brother. That he served several tours in the Revolutionary War. She does not now recollect how many or how long and after the War Howell intermarried Jane Street in the year 1784 in North Carolina. That the said James is the identical person who swore to and subscribed the within declaration. That the data which he is enabled to fix their marriage with precision is by the age of one of her own children who was born in the year they were married.
