[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Virginia Randolph County: SS

On this 24 day of June 1833 personally appeared before me David Holder a Justice of the Peace in and for said County of Randolph Ambrose Lipscomb a resident of said County of Randolph aged Eighty-one years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7<sup>th</sup>, 1832. That he entered the service of the United States under the following named Officers to wit: In the month of March in the year 1781 he was drafted for four months service in the Virginia militia in the Company commanded by Captain William Frost he resided in the County of Frederick in the State of Virginia when he was drafted and was marched from thence to Richmond Virginia and from thence to Wilton's Camp and there joined the troops under the command of General Lafayette he has forgotten the name of the Colonel to whose Regiment he belonged he continued under General Lafayette until his four months expired when he was discharged he things [sic, thinks] his discharge was signed by Captain Frost he has lost it he returned to Frederick County Virginia and again in August or the 1<sup>st</sup> of September 1781 in the said County of Frederick he was drafted for three months in the militia in the company commanded by Captain George Bell was marched from thence to Little York in Virginia and joined General George Washington's Army at that place he does not recollect the name of the Colonel to whose Regiment he was then attached to he was at little York during the "Siege of York" when Lord Cornwallis surrendered [October 19, 1781] to General Washington after the surrender he remained a short time to guard the prisoners and when the prisoners were marched from little York to Winchester Virginia he aided in guarding them to that place and when his three months expired he was discharged his discharge was signed by Captain Bell one Henry Cuttell was Lieutenant under Captain Bell. He has no documentary evidence neither does he know of any person by whom he can prove his services. To the first interrogatory directed by the regulations of the War Department he answers that he understood from his parents that he was born in the year 1762 [?] but has forgotten the place. To the 2<sup>nd</sup> he answers that he has no record of his age. To the 3<sup>rd</sup> he answers that he was living in the County of Frederick when called into service after the Revolution he lived one year in King George County Virginia and then returned to Frederick County remained there some time & from thence to Randolph County Virginia his personal residence. To the 4<sup>th</sup> he refers to what he has already stated in his

declaration as containing as full an answer as he is enabled to make. To the 5<sup>th</sup> he makes the same answer. To the 6<sup>th</sup> the same and that his discharges have been lost. To the 7<sup>th</sup> he states that he is known to John Taggart, a clergyman John White & John Long in his present neighborhood who can testify to his character for veracity and their belief of his services as a soldier of the Revolution. He hereby relinquishes every claim whatever to a pension or an annuity, except the present and he declares that his name is not on the Pension roll of any agency in any state. Sworn to and subscribed the day & year aforesaid.

S/ Ambrose Lipscomb, X his mark [John Taggart, a clergyman, John Long and John White gave the standard supporting affidavit.]

[p 7: On May 6, 1846 in Preston County Virginia, Winny Lipscomb, 78, filed for a widow's pension under the 1838 act stating that she is the widow of Ambrose Lipscomb, a revolutionary war pensioner; that she married him in December 1785; that their marriage took place in King George County Virginia; that her maiden name was Winny Mardis; that she has no record of her marriage but refers to the register of the birth of her children; that her husband died May 18, 1841. She signed her application with her mark.]

[p. 8: On May 6, 1846 in Preston County Virginia, Henry Lipscomb gave a supporting affidavit as to the date of death of the veteran; his marriage to Winny and the register of the family record of the births of the children of the veteran and his wife signed by the affiant. He does not state his relationship, if any, to the veteran or his wife.]

[Veteran was pensioned at the rate of \$23.33 per annum commencing March 4<sup>th</sup>, 1831, for service as a private for 7 months in the Virginia militia. His widow was pensioned in a like amount.]
