Pension application of Henry Mayner (Maynor) W8268 Catharine Mayner f64NC Transcribed by Will Graves 4/20/09: rev'd 7/22/16

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of South Carolina Edgefield District: SS

On this \_\_ day of June 1819, before me the Subscriber Henry W. Desaussure one of the Judges of the Court of Chancery of the said State, personally appears Henry Mainor [sic] aged about fifty-five years resident on Savannah River in Abbeville District in the said State, who being by me first duly sworn according to law, doth on his oath make the following declaration in order to obtain the provision made by the late act of Congress entitled "an act to provide for certain persons engaged in the land & naval service of the United States in the Revolutionary War:" That he the said Henry enlisted in Onslow County in the State of North Carolina in the Company commanded by Capt. William Litle [sic, William Lytle] of Hillsboro, belonging to Col. Archibald Litle's [sic, Archibald Lytle's] Regiment, of the United States regulars North Carolina line about the month of June 1787 [sic, 1777?]; that he continued to serve in the said Corps in the service of the United States until the early part of July in the following year when he received a furlough, permitting him to go at large till called upon, at Charleston in the said State; the troops being dismissed from service before the term had expired for which he was enlisted was the reason of his receiving a furlough instead of a discharge; he further deposes that he was never again called on & that his furlough got wet & was destroyed, so that he can furnish no evidence now that he is on affidavit; that he was at Ashley Hill under General Greene [Nathanael Greene] when the news arrived of Cornwallis's defeat [Yorktown, October 19, 1781], but never was in any engagement, General Greene being induced to suspend his intended operations against Charleston, by the intelligence of Cornwallis's defeat, he further states that he is in reduced circumstances & stands in need of the assistance of his country for support; and that he has no other evidence now in his power of his said Services.

State of North Carolina Secretary's Office 24th of July 1819

I William Hill Secretary of State in & for the State aforesaid, do hereby certify that it appears from the musterroll of the Continental line of this State in the Revolutionary war, that Henry Mayner a private in Capt. Lytle's Company of the 10th Regiment<sup>1</sup> was mustered some time in 1782 for the term of 18 months. The time of his discharge is not stated.

State of South Carolina

On this nineteenth day of March 1821 personally appeared in open court before the Court of Common Pleas of said State being a court of Record now sitting in Abbeville District, Henry Mayner, aged about fifty-seven years resident in Abbeville District aforesaid who being first duly sworn according to law doth on his oath declare that he served in the revolutionary war as follows: viz. in Capt. William Little's [sic, Lytle's] company of Col. Archibald Little's [sic, Lytle's] Regiment; that March for, 1819 is the date of his original application 14069 the number of the Pension certificate under which he has hitherto received a pension.

And I do solemnly swear that I was a resident Citizen of the United States on the 18<sup>th</sup> day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18<sup>th</sup> day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed



[p 14: On March 19, 1850 in Russell County Alabama, John D Maynor and Jesse Maynor filed a claim in which they state that they and William H Maynor are the sons and only living a heirs of Henry Maynor formerly of Abbeville District but lately of Harris County; that Henry Maynor is their father and was a revolutionary soldier pensioned under the 1818 act; that their father died about July 3<sup>rd</sup>, 1838 and left a widow named Cata Maynor "In sain" [insane?]; That they know not whether she is alive or dead but she has not been heard from for several years; that they

believe their father served 2 terms of service in the revolutionary war in place of his brother Jacob Maynor and one tour in his own name.



[p 45: On February 15, 1853 in Montgomery County Alabama Henry W Collier gave testimony that in or about the year 1816 Catherine (familiarly called Katy) Whatley lived in the family of the affiant's uncle Edward Collier in Abbeville District South Carolina; that in the same district there lived in the neighborhood a man by the name of Maynor whose Christian name the affiant believes was Henry; that between 1816 and the 1<sup>st</sup> of January 1819 said Katy and Henry were lawfully married.]

[p 12: In Russell County Alabama, on February 22nd, 1853, Catherine Maynor of said County made oath before William H Maynor, notary Public, that she is the widow of Henry Maynor deceased; that she married him in Abbeville district South Carolina about the middle of January 1816; that they were married by Esquire Colier; that her husband died July 3, 1838; that she is entitled to a land warrant for 80 acres for the services of her husband in the War of 1812. She signed this document with her mark.]

[Veteran was pensioned at the rate of \$8 per month commencing June 7<sup>th</sup>, 1819, for service as a private for one year in the North Carolina Continental line. His widow was pensioned in a like amount.]
