Pension application of Elijah McGuire W8274 Everet McGuire f59SC

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later intereenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

The State of Alabama Tuscaloosa County

On this twelfth day of October 1827 personally appeared in open Court, being the Circuit Court for the County aforesaid, and a Court of Record, according to the laws of said State, Elijah McGuire a resident of said County; aged about Seventy years and nine months, who being first duly sworn according to law doth on his Oath, make the following declaration, in order to obtain the Provision made by the Acts of Congress of the 18th March 1818 and the 1st May 1820, that he the said Elijah McGuire was enlisted for the term of three years on or about the 17th day of August in the year 1777 in the State of South Carolina, in the company Commanded by Capt. Uriah Goodwyn [Uriah Goodwin], in the Regiment commanded by Col. Thompson [William Thomson, SC 3rd Regiment] in the line of the State of South Carolina, on the regular Continental establishment, that he continued to serve in said Corps for some time, but the exact time not now recollected until he was regularly discharged into Capt. John Buchanan's Company [SC 6th Regiment], in which he continued to serve as orderly Sgt. until he was made a prisoner of war by the British at the capture of Charleston, South Carolina [Charleston South Carolina fell to the British on May 12, 1780] in whose custody he remained a prisoner, until the expiration of the term for which he had enlisted, -- After which having escaped from their custody, he again entered the Service of the United States immediately in a Company of Cavalry commanded by Capt. Philip Waters [Philemon Waters], attached to the Brigade commanded by General Sumpter [Thomas Sumter], in which he continued until the termination of the Revolutionary War; that he hereby relinquishes every claim whatever to a pension except the present, and that his name is not on the roll of any State except that of South Carolina and that the following all the reasons for not making earlier application for a pension that he is a man of limited information, that he has rarely associated but little with the world; and that not until within the last six months was he apprised of the laws above referred to or any other by which he could obtain a pension from his Government. And in pursuance of the act of the first of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor

have I any income other than what is contained in the schedule hereto annexed and by me subscribed, That since the 18th day of March 1818 no changes have been made in my property, that I am by profession a farmer, enfeebled by age and consequent infirmities, and now badly able to pursue it, and that an infirm wife of nearly my own age, from whom I receive no assistance; but who claims support from my hands, constitutes my family.

[image 223: On April 29, 1844 in Tuscaloosa County Alabama, Everet McGuire filed for the balance of the pension due to her husband at the time of his death. She also executed a power of attorney authorizing her attorney [Elijah McGuire Junior] to pursue the pension due to her husband from September 4, 1843 to December 31st, 1843 when he died. In her application, she states that her husband resided in Tuscaloosa County Alabama for the space of 24 years before his death and that prior thereto he lived in the State of Tennessee She signed these documents with her mark.]

[image 225: Also on April 29, 1844 in Tuscaloosa County Alabama, Elijah McGuire Junior signed a statement stating that the foregoing power of attorney was given to him without his having received any interest in the subject thereof by sale transfer or mortgage.

[image 265: On June 14, 1844, Moses McGuire in his capacity as clerk of the County Court of Tuscaloosa County Alabama certified that satisfactory evidence had been produced in court by Everet McGuire widow of Elijah McGuire that her husband died on the 31st day of December 1843. His relationship if any to the veteran and/or his widow is not stated.

[Facts in file: On February 9, 1855, proof was offered by Isaac Lee, aged 75, William H. Terrell,

72, and John W. Prewett, 66, all of Tuscaloosa County Alabama of the marriage of Elijah McGuire and his wife Everet; that they had the following children: John McGuire, the oldest child who they believe to be about 70 years old and a resident of Tuscaloosa County; Elijah McGuire Junior, 67, also a resident of Tuscaloosa County; Amos McGuire, aged about 65 and a resident of Chickasaw County Mississippi; Merry McGuire aged about 62 and now residing in Tuscaloosa County; William McGuire, aged about 59 and now residing in Chickasaw County Mississippi; Polly Spears, aged about 56, wife of John Spears, residing in Fayette County Alabama; Moses McGuire, aged about 53 years and now residing in Tuscaloosa County; Rhoda Whatley, aged about 50 years and now residing in Tuscaloosa County; and that the following is a true transcript from the family Bible:

"Elijah McGuire, Senior, was born in Cumberland County, Virginia on the 19th of January 1757 Elijah McGuire Senior departed this life on Sunday the 31st of December A.D. 1843 aged 87 years, 11 months and 11 days at about 10:00 PM.

Everet Maguire, widow of Elijah McGuire, Senior, died on Monday Morning the 17th July 1848 at about 7:00 AM aged about 87 years. The two were buried at John Thomas 'on Byless [could be "Bylers"] Road 16 miles North of Tuscaloosa -- their remains rest side by side."]

[Veteran was pensioned initially at the rate of \$96 per annum increased to the rate of \$145 per annum commencing March 4th, 1831 and ending with his death on December 31, 1843. The pension was based on the veteran service as a sergeant in the South Carolina Continental line and subsequently in the militia. His widow was pensioned in a like amount.]
