Pension application of Anthony Mullen (Mulens, Mullins, Mullens)¹ W8280 Sarah f29VA Transcribed by Will Graves 8/1/13

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

State of Tennessee Lincoln County

Anthony Mullins makes the following declaration in order to obtain the benefit of an act of Congress passed 1828. That in the month of February 1777 as he thinks he enlisted at Fredericksburg Virginia under Captain William Barret [also spelled William Barrett] for three years – in the Regiment commanded by Colonel William Washington. From thence he went to Frederick Town in Maryland & there remained during the winter. From thence to Philadelphia – he remained in said Regiment until a short period before the expiration of the time for which he enlisted during which time he was engaged in the battle at Tarltons defeat [Tarleton's Defeat or the Battle of Cowpens, January 17, 1781], battle at Guilford [Guilford County Courthouse, March 15, 1781] – in Hillsboro – at the defeat of Williams [perhaps a reference to Hezekiah Williams] the Tory, battle of Ninety Six [Siege of Ninety Six, May 21-June 19, 1781] – and frequent skirmishes – he continued to serve in said Regiment until when at Cross Creek in North Carolina he enlisted for during the war. This last enlistment was a very short time indeed before the expiration of the three years for which he had previously enlisted – he was then marched to Charleston – he was in the battle of Ninety Six after he enlisted for during the war – he continued his services without intermission until the termination of the war. He continued to serve in the same Regiment but under different captains, the last Captain of the company in which he served was Churchwell Jones [Churchill Jones] – He is now in his seventy eighth year – exceedingly feeble indeed so much so that he is entirely unable to support himself & family by his labor, that being his only means of support, he is a farmer never having learned any mechanical trade. He was regularly discharged at Richmond Virginia but his discharge was destroyed about 17 years since in his house when it was consumed by fire. He has 10 in family, consisting of 4 sons - 4daughters himself & wife – he has had 18 children, but has only the ones above mentioned living with him. The eldest a son of 19 years and only one able to assist him in his labor – he has the following property –

2 mares worth	\$50
4 cows	\$20
4 calves	\$4
3 [indecipherable]	\$6
4 Sows 13 pigs	\$10

3 indifferent beds \$15 and some other property such as chairs, pots, table, &c altogether worth about the sum of \$10. He has not conveyed any of his property to others.



widow's pension under the 1853 act stating that she is the widow of Anthony Mullins; that she married him in November 1808; that her husband died November 3, 1836. She signed her application with her mark.]

[p 12: On September 16, 1854 in Lincoln County Tennessee William Mullins, about 66, and Andrew Mullins, about 55, filed an affidavit in which they state they are the sons of Anthony Mullins by a former marriage; William Mullins testified that he has a very distinct recollection that he was present at the wedding of his father to Sarah Rambles in the County of Albemarle in Virginia some 45 or 50 years ago; both witnesses testify that their father died in Lincoln County Tennessee on or about November 3, 1836 and that his widow remains unmarried.
