Pension application of Joseph Baker W8339 Transcribed by Will Graves Susanna Baker

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

To the Honorable W. L. Kelly circuit Judge of the Garrard Circuit Court, the petition of Joseph Baker for a pension under the act of Congress in favor of revolutionary soldiers.

Your petitioner states on oath that he enlisted as a regular soldier at Hillsborough in North Carolina for the term of 12 months under Captain John Wilson and went with said Wilson to Wilmington, and was at Wilmington Incorporated into the 10th Regiment of the Continental Army commanded by Colonel Zachariah Dozier [Zachariah Dauge]; that he continued at Wilmington until the time was out, and obtained his discharge at that place, that he enlisted again under the same officer for the term of 6 months and served out the latter term at the same place, he was stationed at the barracks in Wilmington during the whole of the time aforesaid and that he obtained a discharge under the same instrument for both terms of service which discharge he left at the mouth of the Kanhaway [Kanawha River] as he came to the backwoods country, that he is now in his sixty eighth year, and is very infirm and in indigent circumstances, by which he is in need of assistance from the General government. He states that he knows no person at this distance of time by whom he can prove his service in this part of the world.

Amended petition & Schedule of Joseph Baker

District of Kentucky

On this 21st of August 1820 personally appeared in open court, being the County Court of Garrard being a Court of record in said District Joseph Baker aged about Sixty-nine years resident of Garrard County in said District who being first duly sworn according to law doth on his oath declare that he served in the revolutionary war as follows. He enlisted in the year 1780 with Captain John Wilson in the 10th North Carolina Regiment, commanded by Colonel Zachariah Dozier [Zachariah Dauge] for the term of 12 months on Continental establishment and served out his term and obtained an honorable discharge which he has lost. He further states that in a few days after the said term was out he again enlisted for the term of six months and served out the said term and obtained a discharge for the same, together with his former service together.

And I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or otherwise disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any

income other than what is contained in the schedule hereto annexed and by me subscribed to wit:

One horse beast of the value of ten dollars & no more	\$10
Six head of cattle of the value of forty dollars & no more	40
Five head of hogs of the value of ten dollars and no more	_10
making in all sixty dollars	\$60

That he owes about \$40.

His occupation is agriculture, that he has a wife about fifty years of age living with him. That he has ten children, that he has but three living with him, two boys & one girl – one of the boys about 13 & the other about 15 years of age, the girl is between seven & eight years of age. The rest live to themselves.

Sworn to and declared on the 21st August 1820.

It appears from the Journals of the Old Congress that there were Company stationed at the different Seaport Towns in the State of North Carolina in the revolutionary war, of these Companies no musterrolls have been returned, it is believed from the declaration of this applicant that he belonged to a company stationed [at] Wilmington. State of Kentucky, Garrard County

On this 20th day of August 1832, personally appeared in open Court, before the Justices of the Garrard County Court now sitting, Joseph Baker, a resident of Garrard County in the State of Kentucky, aged 77 years, who being first duly sworn according to law, doth on his oath, make the following declaration, in order to obtain the benefit of the Act of Congress passed June 7th 1832.

He states that he enlisted in the Army of the United States in the year ___, in Hillsborough in the State of North Carolina, Orange County, for the term of one year, and the 10th Regiment under the command of Captain John Wilson – the Regiment to which he was attached was commanded by Colonel Zachariah Dozier --

That he marched to Wilmington at the mouth of Cape Fear River, and continued there in the service, under the command of the above officers for 12 months.

After the expiration of the above, he again enlisted under the same officers for six months, and was stationed the whole of said period at the mouth of Cape Fear River--

He states that he was engaged in no battle, but whilst stationed at Wilmington he saw General Washington --

He has no documentary evidence in his possession of his Service --

He hereby relinquishes every claim whatever to a pension or annuity except the present, and declares that his name is not on the pension roll of the agency of any State.

Sworn to & subscribed the day and year aforesaid.

[p 14: On October 20, 1838, in Garrard County, Kentucky, Susanna Baker, 76, filed for a widow's pension stating that she is the widow of Joseph Baker, a pensioner of the United States, that she married said Baker in Wythe County in Virginia in 1778; and that said Joseph Baker died March 1, 1838. She signed her application with her mark.]

[p 15: On October 25, 1838, Abraham Baker gave an affidavit saying that he is the second child of Joseph Baker and Susanna Baker; and that he is now 52 years old. He signed his affidavit with his mark.]

[Veteran was pensioned at the rate of \$60 per annum commencing March 4th, 1831, for service as a private for 18 months in the North Carolina service. His widow was pensioned in a like amount.]
