Pension application of Wilson Maddox W8413 Delilah Maddox f53VA

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

State of Kentucky Shelby County Sct.

On this 17th day of September 1832 personally appeared in open Court before the following Justices to wit Benoni L. Newland, Robert T Robb and Geo. P. Miller composing the County Court of Shelby now in Session as a Court Wilson Maddox a resident of the County of Shelby and State of Kentucky aged seventy-seven years, who being first duly sworn according to law, doth on his oath make the following declaration in order to obtain the benefit of the provision of the Act of Congress passed June 7th 1832 for the benefits of the acts of Congress passed May 15th 1828. That he enlisted in the Service of the United States in the month of January 1778 under Thomas Dillard the Lieutenant in Captain Donaldson's [John Donaldson's] Company for the Term of three months and served in the Regiment of Colonel George Rogers Clarke [George Rogers Clark] who at that time commanded the troops in the Western Country, that he was in the state line of Virginia, that when he enlisted in the service he lived in the State of Virginia Charlotte County, but enlisted in Pittsylvania County State of Virginia under the aforesaid Officers, that he was in Captain Donaldson's Company although not enlisted by him but by his Lieutenant Thomas Dillard, that there was but one Regiment commanded by Colonel Clark as aforesaid, that after he enlisted he marched under the command of Lieutenant Thomas Dillard through the wilderness from Pittsylvania to Kentucky County and landed at Boons Borough [Boonesborough] on the 26th day of March 1778, that Captain Donaldson's company remained some time under the command of Dillard at Boonesborough until about ten days before his time of service expired, when Colonel Clarke sent an express from the falls of the Ohio to Boonesborough for Captain Donaldson's company to go on to the falls of the Ohio, that the Company went according to said command forthwith to the falls of Ohio, that there Captain Donaldson's company joined for the first time Colonel Clarke, that at the falls of the Ohio his term of three months enlistment expired, that from this Term of three months he was not discharged, he being in a foreign and wilderness country, he could not return with safety if he had desired the same that he at Harrodsburg again enlisted under Captain James Harrod, who formed one of the Companies of said Colonel Clark's Regiment, that the said Harrod's Company remained at the Fort at Harrodsburg until May 1779, when he was detailed ordered to march from said Harrodsburg under Captain Sigh Harland [Silas Harlan] to Chillicothe on the Little Miami River, that at this time the Regiment was commanded by Colonel John Bowman, he thinks in the Regiment there was about 280 men & officers, that at this place the Indians gave Colonel Bowman an action when Colonel Bowman had to retreat to Harrodsburg, that Colonel Bowman was then acting as under Colonel Clarke who as this affiant understood was the commander in chief of the armies in the Western Country, that he remained at Harrodsburg or the forts in its vicinity under Colonel Bowman until sometime in 1780 when he was by the order of

Colonel Bowman placed under the command of Captain Thomas Denton and ordered to march to the mouth of the Licking where Captain Denton's joined Colonel Clark's Army, of something like of a thousand men and officers, that from the mouth of Licking now Cincinnati Colonel Clark's Regiment marched to the Pickerway [Pickaway] Plains where Colonel Clarke gave the Indians an engagement and defeated them and burnt their huts, and destroyed their corn, that in this engagement some Indians were killed, that from this place the whole Regiment returned to the Ohio River where Colonel Clarke descended the River Ohio and the company of Captain Denton came on to Harrodsburg, that this affiant was still under the command of Colonel Bowman and under his order was guarding and building new forts in Kentucky County until 1782 when this affiant was placed under the command of John Dougherty Captain and ordered by Colonel Bowman to march to the Big Miami River under the command of Colonel Clarke who they joined at the mouth of Licking now Cincinnati again that Colonel Clark's Regiment whipped the Indians and took some Indian prisoners and retook some white persons in capture [captivity] by the Indians one woman by the name of McFall. That the Regiment of Colonel Clarke then returned to Cincinnati, he Colonel Clarke returned to the falls of Ohio and this affiant returned home to Harrodsburg. That all this service was done from the time of his first enlistment aforesaid as a regular Soldier subject to orders and duty at all times, that he faithfully served out all the duty that was required of him which was all the time, that from this service he never received a regular discharge, but was placed under so many commanders, that none felt it their duty to give discharges, that he knows of no one by whom he can prove the aforesaid services, that he has no documentary evidence of said services.

He hereby relinquishes every [claim] whatever to a pension or annuity except the present, and he declares that his name is not on the pension roll of any State in the union.

[p. 12: affidavit dated July 27, 1839 signed by David Maddox and Thomas G Maddox of Shelby County Kentucky in which they state they are the committee appointed by the Shelby Circuit Court to take care of Delilah Maddox, widow of Wilson Maddox; that she is insane and committed to their care.

[p. 13: On December 9, 1839 in Shelby County Kentucky, Thomas G Maddox and David Maddox the committee for the care of Delilah Maddox, widow of Wilson Maddox, filed a claim for a widow's pension under the 1838 act stating that she married Wilson Maddox more than 50 years ago (the exact date cannot be stated as the family record is now in the war office); that Wilson Maddox died the last of June 1834.]
