Pension application of John McKee ¹ W8446 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

"On this 31st day of August 1829, Our Dear Edward departed this transitory Life aged 29 years, and through the all sufficient Merits of our adorable Redeemer and Glorious Advocate, I humbly trust, reposes in the Bosom of our God.

On the 9th day of September 1834, in the 74th year of his Age Departed this Life, John McKee, My Beloved Husband, upwards of Fifty years, who has been our sojourn here, in Sorrow and in Joy, and Blessed be the God of my Mercies, Methinks I hear the Voices of my loved ones gone before Chanting Hallelujah around the Thrown, to the Great Eternal! in whose presence is "fullness of Joy and Pleasures evermore!" And now Lord I wait for thy Salvation! And when the Bridegroom shall say he "Come" May thine Handmaiden be found Watching as one who waiteth for the Coming of her Lord! And may she be enabled with all the Redeemed ones to exclaim, Thanks be to God who giveth us the Victory through our Lord Jesus Christ! Amen and Amen."

Henry, son of John and Margaret McKee was born September 6th 1811 Our loved Louisa departed this transitory Life on the 30th of April 1822 aged Eighteen years. Our ever dear Anna departed this life on the [illegible] of December 1823 aged 22 years. Our ever dear and beloved Henrietta departed this Life on 14th of August 1825, aged 29 years.

[p 15] State of South Carolina Beaufort District

On this 18th day of January in the year of our Lord 1851 personally appeared before me John M. Baker a Magistrate appointed to keep the peace and duly commissioned under the great seal of the State, Mrs. Margaret McKee, a resident of the town of Beaufort in the District in State aforesaid, aged Eighty four years who being first duly sworn according to law, doth, on her oath make the following declaration, in order to obtain the benefit of the provision made by the Act of Congress passed on the 7th day of July 1838 entitled "an Act granting half pay and pensions to certain widows," that she is the widow of John McKee who was a private soldier in the war commonly called the Revolution, having entered the service as a volunteer at the age of 16 years in a company raised on the island of St. Helena and commanded by Capt. Jenkins [John Jenkins], which company was attached to a Regiment commanded by Col. Barnwell, that he marched thence to Purysburg where he was mustered into the service, and that he served several years, that he was present and engaged at the battle of Stono [June 20, 1779] and that he was also at the Siege of Charleston [Charleston South Carolina filter the British on May 12, 1780]; that he received after the close of the war, compensation for a portion of his term of service, which compensation was paid in guineas. She further declares that she was married to the said John McKee on the 9th day of March 1784 by Rev. James Graham; that she has no other record of her said marriage than the entry in the family Bible now in her possession that her husband the aforesaid John McKee died on the 8th day of September in the year 1834 in the 74th year of his age, that she was not married to him prior to his leaving the service; but the marriage took place previous to the first of January A.D. 1794, to wit on the day and in the year above stated. She further declares that she is now a widow, and that she has never before made any application for a pension.



[Veteran was awarded a pension at the rate of \$30 per annum commencing March 4th 1831 and ending September 8, 1834 for his service as a private for 9 months in the South Carolina militia. The pension was awarded posthumously based on the application of his widow. His widow was pensioned in a like amount.]
