[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

State of Kentucky Henry County: SS

On this 1st day of October 1838 personally appeared before John Chilton, John Wooden, David Adams, James Walker, Samuel Ireland, Thomas M Jullard, Thomas B. Hancoett, William O'Bannon & John [illegible] Judges of the County Court of Henry County Kentucky now setting Priscilla Merewether a resident of Kentucky in the County of Henry aged 67 years and upwards who, being first duly sworn according to law doth on her oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed July 7th 1834 – entitled an act granting half pay and pensions to certain widows. That she is the widow of Valentine Merewether who this declarant always understood and believed was a Lieutenant in the Army of the revolution But this declarant will not undertake to state the particulars of the service of her husband as he the said Valentine Merewether made a declaration in his lifetime<sup>1</sup> and after the death of the said Meriwether a certificate was issued to this declarant allowing her for the service of said Valentine Merewether at the rate of \$160 per annum from the 4th day of March 1831 until the death of the said Valentine Merewether which was in August 1832. She further declares that she was married to the said Valentine Merewether on the 27th day of December in the year 1790 in Fairfax County State of Virginia as will more fully appear by the proof hereunto annexed – that her husband the aforesaid Valentine Merewether died on the 15 day of August 1832 that she was not married to him prior to his leaving the service – but the marriage took place previous to the 1st of January 1794 viz. at the time above stated. Sworn to and subscribed in open Court on the day and year above written.

I Jesse Alvis<sup>4</sup> aged about 76 years do hereby Certify on oath that I was well acquainted with Lieutenant Valentine Merriwether in the year 1777 in the State of Virginia and do well know Lieutenant Merriwether entered the Army of the Revolutionary War in the year 1777 as a Lieutenant in the Virginia State and Continental line and I do well know he remained in the Army up to the latter part of the year 1780 or the first of 1781 at which time he was marched to the West. I verily believe he entered the Army for during the war and served to the close of the same and was honorably discharged – I also knew Lieutenant Merriwether in the State for many years and have had various lengthy conversations of our Troubles and Sufferings while in the Army and contending for our Liberty. I was well acquainted with Lieutenant Merriwether's wife whose name is Priscilla and lived his neighbor in Virginia and also in this State and further saith not.



Also appeared before the said Oldham County Court in the State of Kentucky on the 21st July 1834, Priscilla Merriwether who states upon oath that she is about 63 years of age, that she was married to Volentine Meriwether in the State of Virginia Fairfax County in the year 1790, that in relation to the services of her deceased husband in the war of the revolution his statements have been very numerous although my recollection is much impaired by reason of age and trouble but will state those facts only which I firmly recollect to have heard my deceased husband so repeatedly talk about – My husband Volentine Merriwether entered the Army of the revolutionary war in the spring of 1777 and continued an officer till the close of the war he stated many of his brother officers a few names only I now recollect this Colonel Gibson, General Clark, Major Thomas Massee, Captain George Catlett, Captain Thomas Young, Colonel Montgomery, Colonel William Crawford, Captain John Ashley, Colonel Stevenson, Colonel Thomas Marshall, and many others and when general Lafayette visited the Western Country and while at Louisville General Lafayette sent a special messenger to my husband Volentine Merriwether for him to come to Louisville to see him. Mr. Merriwether feelings glowed with sentiments of joy for that distinguish man whom he had so often walked with in the path [of] danger and called the Marquis the brother in arms the soldier in battle Mr. Merriwether was then in a weakly state of health and unable to go to visit his old brother as he called him the Marquis Lafayette, and distinctly recollects it was with my utmost persuasions that I kept him from going which [I] did with a view to not let him endanger his remaining a few days that some few weeks before he died he began to make out his claim for an allowance of his pension but took his bed and was unable to attend to it he then sent for Mr. Armstrong a very able Lawyer but Mr. Meriwether was so far spent that I would not permit the Gentlemen to attend to that business although Mr. Meriwether had made some progress in the papers but those papers were lost and mislaid.

Meriwether stating that they are the heirs of Valentine Meriwether and that they have never received any bounty land for his service in the revolutionary war.
