Pension application of Samuel Cross W8636 Elizabeth Cross Transcribed by Will Graves 6/8/11: rev'd 2/27/20

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Abbeville District South Carolina: To the Honorable the Members of the Senate and House of Representatives of the State of South Carolina: The humble petition of Samuel Cross, sheweth That early in the war of the Revolution your petitioner enlisted in the services of his Country under Captain John Smith [John Carraway Smith], that soon after his enlistment he was sent him & joined Colonel Thompson's [William Thomson's] Regiment at Augusta, that soon after that time he was marched to Stono & was at the engagement [Battle of Stono, June 20, 1779] there, that after the first term of service expired he again enlisted under Captain Winn [Richard Winn] of the same Colonel Thompson's Regiment, after this he was at the siege of Savannah, that after the expiration of his second term of service, he again enlisted for three years, that during this term of service he was taken prisoner at Charleston [Charleston South Carolina fell to the British on May 12, 1780]² & confined in a prison ship he remained a prisoner ten months, after this he escaped went up the country and entered the militia service under Captain John Gray of Fairfield District that he was marched from there and was at the battle of Eutaw Springs [September 8, 1781] after that he returned home & joined another company of militia under Captain Charnel Durham was marched to the Four Holes and remained there two months, this was about the close of the war. That in the whole in the regular & militia service your petitioner served about five years. Your petitioner is now about Eighty years of age is unable to labor for a support and he has a wife about sixty years old who is crippled in one hand. That now in his old age he is reduced to indigence & relies solely on his Country for support. Your petitioner therefore prays that your Honorable Body would take his case into consideration & grant him such relief as in your wisdom you may think meet and as in duty bound he will ever pray.

South Carolina Fairfield District: Personally appeared Captain John Smith and makes oath that in the year 1779 he enlisted in the regular service of the United States and joined the 3rd Regiment at Purrysburg in the spring of that year. Deponent is well acquainted with Samuel Cross late of Fairfield but now of Abbeville District & is of opinion Cross belonged to that Regiment at the time he joined it, deponent knows that Cross was a regular soldier & continued in the Army & was captured by the enemy at the fall of Charleston in 1780 (May) after that event deponent fully believes Cross was his fellow prisoner on board of the *Eske* and in February 1781 he in company with several American soldiers confined on board said ship, made his escape from the enemy & took refuge in the upper Country. Sworn to before me this 3rd of July 1820 [sic, 1826?]. S/ James Marshall, JP

Personally appeared before me Captain Charnel Durham³ and makes oath that he is well acquainted with Samuel Cross formerly of Fairfield & now of Abbeville District. Deponent was a regular soldier in the 3rd Regiment of Continental troops commanded by Colonel William Thompson [William Thomson] – he knows very well that Cross was a regular soldier in said Regiment for three years & that he enlisted under Captain Richard Winn and 1775 or 1776 – Cross was captured by the enemy at the fall of Charleston in May 1780, and sometime in the next year he made his escape – and returned with several associates to the back country. After this Cross joined a Company of militia commanded by Deponent and did duty for some time under him. He always supported the character of a brave man and a true & faithful soldier. Sworn to before me this 3rd July 1826.

[p 16: On the 19th day of June, 1851 in Fairfield District, South Carolina, William Francis Pearson, 61 gave testimony that he has a record of his age in the handwriting of his father Philip Pearson and that he was born on June 24, 1784; that his father was a justice of the peace before and during the Revolution; that there were many revolutionary officers and soldiers who bore the undisputed reputation's as such including Major John Pearson, Captain John Gray & Captain Charnel Durham, Captain Andrew Gray & Captain Frederick Gray, Lieutenant James Kincaid and many privates including Samuel Cross; that he was well acquainted with Samuel Cross and lived within 2 miles of him; that he knows that Samuel Cross and Elizabeth lived together as man and wife; that he knew Elizabeth Cross' brother John Finley; that affiant was a schoolmate of the children of Samuel & Elizabeth Cross including their oldest son John who was some 2 years older than himself; that he has been a magistrate for about 40 years; that about 39 years ago he married Mary the daughter of Samuel and Elizabeth Cross to her husband Charles Dansby.]

[p 43: Certificate dated May 14, 1855 from the South Carolina Comptroller General listing indents showing payments to Samuel Cross for military service during the revolutionary war including 185 days service in the horse and 35 days in the foot in the militia in 1781 and 1782.]

[Facts in file: Veteran married Elizabeth Finley in April 1781; their first child was John, 2nd child named Susan, 3rd child named William was born about 1788 or 1789; Mary born in 1793; Margaret born about 1795 or 6: Martha, now Mrs. Martha Marsh was born October 18th 1799;

that there is no family record because the veteran and his wife were both illiterate and could neither read nor write; that the veteran died April 28, 1828; that their mother was pensioned by this state and received such pension until her death September 28, 1840; all of the children of the veteran and his wife except Mary and Martha were dead by 1855.]

[Veteran's widow was granted a pension of \$85.18 per annum commencing March 4th, 1836 and ending September 27th, 1840.]

The petition of Samuel Cross humbly Sheweth

That your petitioner served as a regular soldier in the Regiment of Rangers commanded in the late war by Colonel William Thompson [sic], that he was twelve months in actual Service

and after the siege of Charleston confined a prisoner by the enemy four months in the barracks and five months in the prison ship.

That he suffered great hardships the effects of which he feels in his advanced age; that he has a large family to support and has never received any compensation for his services. Your petitioner further states that sometime in the year 1792 he obtained a Certificate from Colonel Thompson by which he procured from David Evans Commissioner of Locations for Camden District a bounty warrant for two hundred Acres of land That from the scarcity of vacant land he never had an opportunity of deriving any advantage from said Warrant.

Your petitioner further states that his neglect to pursue his Claim sooner proceeded from his want of information.

Your petitioner prays that your Honorable House would be pleased to take your petitioner's Case into Consideration and grant him such relief as to your Honorable house shall seem meet.

The petition of Elizabeth Cross Sheweth

That she is the relic of Samuel Cross late a pensioner of this State who died in May last, That your petitioner is very poor having acquired no property since the death of her husband, and in great need of the common necessities of life. That she is about eighty years of age and very infirm and diseased, that with her deceased husband she suffered the toils and privations of the Revolutionary War. She therefore prays you that she may be continued on the pension list in the room of her late husband.
