[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

On motion of Judith C Eggleston, in her proper person, leave is granted her, in order to obtain the benefit of the Act of Congress of the 29<sup>th</sup> of July 1848, she being first duly sworn, according to law, in open Court, to make a declaration in the words and figures following; namely:

That she, the said Judith C Eggleston, is the widow of Joseph Eggleston deceased; that she is a resident of Amelia County in the State of Virginia, and is aged Eighty-two years. That said County of Amelia was the residence of said Joseph Eggleston during his life and that he died therein. That said Joseph Eggleston was an officer in the Revolutionary War, and entered the Army as a Volunteer, as she was informed and believes, while he was a student at William and Mary College, in the Town of Williamsburg in the State of Virginia, not very long after the commencement of the Revolutionary struggle, but at what particular date she does not know. That said Joseph Eggleston entered the Army as a Lieutenant, was subsequently promoted to be a Captain, and subsequently to be a Major of Cavalry; in all which Offices he served at different times, but she does not know the dates of these respective promotions. That said Joseph Eggleston served in one or the other of these offices during the Revolutionary War, and was a Major when discharged at the close of the War; but at what particular time he was so discharged she does not know. That she does not know the Company or Regiment in which he served or to which he was attached; but she was informed and believes that he served in what was known as "Lee's Legion." That she was informed and believes that said Joseph Eggleston was engaged in several battles, and particularly that he fought in the battle of Utah [Eutaw Springs, September 8, 1781] and also she thinks at Guilford Court House [March 15, 1781], and that she is not informed of the Country through which he marched. That most of these facts, she believes will appear by reference to the histories of the War and to the public records, such of which as can now be procured, she will cause to be produced to sustain this declaration.

She further declares that she was married to the said Joseph Eggleston on the 8<sup>th</sup> day of May in the year 1796 as more fully appears by the marriage Bond filed in the Clerk's Office of

The reason there are no surviving papers relating to this bounty land claim is that the offices of the War Department along with the papers filed there were destroyed by fire in 1800 and all pension and bounty land records predating that fire were destroyed. Further, pension and bounty land papers generated between the fire of 1800 and 1814 were lost when the British burned Washington DC on August 14, 1814.

this Court, a certified copy of which she will cause to be exhibited with this declaration; there being no certificate filed in this office or elsewhere known to her; and that her husband, the aforesaid Joseph Eggleston, died in said County of Amelia on the thirteenth day of February in the year 1811; that she was not married to him prior to his leaving the service, but the marriage took place previous to the second of January 1800, viz.: at the time above-stated. She further swears that she is now a widow, and that she has never before made any application for a pension. In witness of which declaration she hereunto signed her name.
