Pension application of Elisha Ford W8821 Sarah Ford f40SC

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

## State of Kentucky Shelby County

Be it known that on this 19th day of August 1833 personally appeared before H. Bohannon a Justice of the peace in and for Shelby County in the State of Kentucky being also one of the Judges of the Shelby County Court, Elisha Ford a resident of the said County of Shelby aged 75 years who by reason of his bodily infirmity is unable to attend the proper court to make his declaration and who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7th 1832.

That he entered the service of the United States under the following named officers and served as herein stated, that is to say. In the month of April in the year 1776 as well as he at present remembers he entered the service of the United States as a drafted militia man and private soldier upon a tour of six months in the company of Capt. Andrew Berry [Andrew Barry] and served as such during the whole of his said tour -- that he was attached to the Regiment commanded by Col. Wingate as well as he remembers. He states that at the time of his said entry into the service he was a resident of Spartanburg County South Carolina that he was immediately upon his said entry into the service marched to Hites [could be Kites] old store and was there kept stationed in a humble Fort which they built under the immediate command of Lieut. John Nesbett [John Nesbit]. He states that there service was against the Indians upon the frontier and upon the termination of his said tour of duty he was discharged and returned home.

He further states and declares that in the month of May in the year 1777 as well as he remembers being still a resident of Spartanburg County South Carolina he again and entered the service of the United States as a private volunteer soldier in the company of Capt. John Berry [John Barry] -- that he was again attached to Col. Wingate's Regiment. He states that this tour was for six months -- that he was marched to the frontiers against the Indians and was there kept during the whole of his tour in order to protect & defend the frontier settlements from the incursions of the savages that during his tour he was engaged in several small skirmishes with the Indians and at the termination thereof having fully and faithfully served out the service he was again discharged and returned home.

He further states and declares that afterwards in the month of January in the year 1778 he again entered the service of the United States as a private volunteer soldier in the company of Capt. John Barry, which was a company of mounted riflemen, upon a tour of six months -- that he rendezvoused with his company at three forks of Tiger [Tyger River] that he was marched from there towards Augusta in Georgia in order to join General Williamson [Andrew Williamson] who lay with his Army on the Savannah River -- that on their route they fell in with

and were attached to the Battalion of Major Brenham [probably Thomas Brandon] and they then all marched on together and joined General Williamson and He states that he was not during any part of this tour under the command of a Col. that he recollects of but that he was under the command of Major Brenham -- that Major Brenham's Battalion was used much as a foraging and scouting party -- he states that during a part of this tour he was in Georgia having been ordered there together with others to assist General Marion [Francis Marion] who was hard-pressed. He states that his services however during this tour were confined principally to South Carolina -- that he continued in the service actually and actively employed during the whole of his said tour and at the termination thereof he was discharged and returned home to Spartanburg County South Carolina where he still resided.

He further states and declares that in the month of May in the year 1781 he again entered the service of the United States as a private volunteer soldier in the company of Capt. John Barry upon a tour of six months -- that the Regiment to which he was attached was placed under the command of Major Tolls [Oliver Towles]. That he rendezvoused with his company at the courthouse in said County of Spartanburg as well as he remembers and he was marched immediately towards Ninety Six and joined the Army under the command of General Green [Nathanael Greene]. He states that he was present and assisted at the siege of that place and continued with General Greene's Army in active service during the whole period of his said engagement and at the termination thereof was discharged and returned to his home in the said County of Spartanburg where he still resided.

He states and declares that from his advanced age, the great lapse of time and his consequent loss of memory, he cannot state the precise times at which he entered the service but from his present best recollection he served in the manner and at the times as are stated -- that he did not serve during the war of the revolution less than twenty-four months as a private soldier and for that service he claims a pension.

He states that he has no documentary evidence and he knows of no person whose testimony he can procure who can testify to his service or any part of it.

He hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension roll of the agency of any State. He Sworn to and subscribed the day & year aforesaid.

Interrogatories put to the above named applicant Elisha Ford by H. Bohannon the said Justice of the Peace

1<sup>st</sup> Where and in what year were you born?

Answer. I was born in Fairfax County Virginia in the year 1757 on 24th November according to my information.

2<sup>nd</sup> Have you any record of your age and if so where is it?

Answer -- I have no record of my age in my possession but have seen it in my father's Bible.

3<sup>rd</sup> Where were you living when called into service: where have you lived since the Revolutionary War and where do you now live?

Answer. I lived in Spartanburg County South Carolina when I was called into the service upon each of my tours and continued to live there for some time after the war and in the year 1799 I moved from South Carolina to Shelby County Kentucky in which County & State I still live.

4<sup>th</sup> How were you called into service; were you drafted; did you volunteer or were you a

substitute, and if in substitute, for whom?

Answer. I was drafted on my first tour and on my others I was a volunteer

5<sup>th</sup> State the names of some of the regular officers who were with the troops when you served, such Continental and militia regiments as you can recollect and the general circumstances of your service.

Answer -- I recollect to have seen Generals Greene & Williamson and Colonels Lee, Washington and Ford -- I cannot at this time call to my mind the name of any other of the officers except those under whom I served. My services in my first and second tours were performed on the frontiers against the Indians. I was engaged in many scouts and performed much active service against them. My services in my third tour were performed in South Carolina and Georgia under the command of Major Brenham and General Williamson. In my fourth tour my Regiment was under the command of Major Tolls [Oliver Towles?] and we were attached to the Army of General Greene. I was present and assisted at the siege of Ninety Six [May 22-June 19, 1781] and was with the Army during the whole of that Campaign.

6<sup>th</sup> Did you ever receive a discharge from the service, and if so, by whom was it given and what has become of it?

Answer I received discharges signed by my officers which I have lost

7<sup>th</sup> State the names of persons to whom you are known in your present neighborhood and who can testify as to your character for veracity and their belief in your services as a soldier in the revolution.

Answer -- I will name William W. Ford & Henry Baskett as persons who live in my neighborhood & to whom I am known.

[William W. Ford, a clergyman, and Henry M. Baskett gave the standard supporting affidavit.]

[p 8: On September 10, 1838 in Shelby County, Kentucky, Sarah Ford, 73, filed for a widows pension stating that she is the widow of Elisha Ford; that she married him March 9 1784 in Newberry County South Carolina; that he died September 29, 1833.

And her Sister Polly was born the 2 day of January 1795 and married the 23 day of September 1812

Sally Ford was born the 16 of September 1797 and was married 16 of Oct. 1813

[Veteran was pensioned at the rate of \$80 per annum commencing March 4<sup>th</sup>, 1831, for service as a private for 2 years in the South Carolina militia. His widow was pensioned in a like amount.]
