[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Commonwealth of Kentucky Caldwell Circuit & County

Be it remembered that there appeared before me Benjamin Shackelford Judge of this 7th Judicial District of this State, Aaron Freeman a Citizen of said County and an indigent Soldier of the Revolution claiming the benefit of the Law of March 18th 1818 for the relief of certain persons engaged in the revolutionary War and relinquishing all pensions or claims to pensions before granted by the United States made & subscribed the following Statement --

That on the first of August 1781 he enlisted with Captain Thomas Armstrong into the Continental Army in Dobbs County North Carolina, & marched to Fayetteville, from thence to the High hills of Santee, where he joined the 2nd North Carolina Regiment of Continental Troops, that being sick he was removed to Cambden [Camden] Hospital and when recovered he was ordered to do duty there as a Guard & did Sergeant's duty from Camden he marched to Salisbury in North Carolina where after being 12 months in the Continental Service he was discharged at Ashley Hill which discharge he has lost.

That now being in reduced Circumstances he needs the Assistance of his Country for support.

State of Kentucky Caldwell County to wit

In the record of proceedings of the County Court of said County among others all the following

Be it remembered "At a County Court begun and held for Caldwell County at the Court house in the Town of Princeton on Monday the 26th day of July 1819 the following proceedings were head to wit

"On motion of Aaron Freeman it is ordered that the following affidavit or statement in writing be recorded and certified which was sworn to hear in open Court, to wit "Commonwealth of Kentucky Caldwell County at a County Court held at Princeton in & for said County on Monday, 26 July 1819 personally appeared Aaron Friedman age 62 years resident in this County who being duly sworn according to law doth on his oath make the following declaration in order

to obtain the provision made by the late act of Congress entitled "an act to provide for certain persons engaged in the land and naval services of the United States in the Revolutionary [War]". That the said Aaron Freeman Enlisted in Dobbs County North Carolina for the term of one year on the 1st day of August 1781 in the company Enlisted by Captain Thomas Armstrong for the 2nd North Carolina Regiment commanded by Archibald Lytle and as well as he recollects, in the line of said State on the Continental Establishment, that he continued to serve in said Corps or in the service of the United States until August 1782 when he was discharged from service at Ashleys Hill [Ashley Hill] in the State of South Carolina, That he does not recollect ever having been mustered that having been taken sick soon after he Joined the Army at the high hills of Santee he was removed to Camden Hospital and when recovered he was ordered to duty with the guard at Camden where he did Sergeant duty. That he is in reduced circumstances & stands in need of the assistance of his country for support & has no other evidence now in his power of his said services except what will be forwarded, And the court being satisfied that the said Aaron Freeman did serve in the Revolutionary war as stated in his declaration against the common Enemy for the time of 9 months or more at one time in the Continental Establishment and also that the said Freeman needs the assistance of his Country for support order of these proceedings recorded and that they transcript thereof be forwarded to the secretary of the department of war pursuant to the directions of the before mentioned act of Congress."

And again to wit at a County Court Continued and held for said County at the Court house aforesaid on Tuesday the 27th day of July 1819, the following proceedings was head to wit "On motion of Aaron Freeman the following affidavit of Arthur Brown is recorded to wit "Arthur Brown an old revolutionary soldier on the pension list under the act of March 18th, 1818 in open court testified and says that he was in 1781 & 1782 when in the Continental Army well acquainted with Aaron Friedman the present applicant for a pension that he knew him as a Continental soldier enlisted for one year and that they frequently did duty together subscribed and sworn to in open Court July 27, 1819.

Which is ordered to be certified to the Secretary of War & accompanied the transcript and record & certificate of said Freeman's application for a pension at the present term.

State of Kentucky Caldwell County

In the Record of proceedings in the County Court of Caldwell aforesaid among other things all the following

Be it remembered that "At a County Court begun and held for Caldwell County at the Courthouse in Princeton on Monday, 24th July 1820" the following proceeding were head to wit "On motion of Aaron Friedman he produced here in Court his affidavit which being Sworn to in open court by said Freeman was ordered to be recorded and Certify according to law.

State of Kentucky Caldwell County: On this 24th day of July 1820 personally appeared in open Court being a Court of Record for said County Aaron Freeman age 63 years resident in Caldwell County, who being first duly sworn according to law doth on his oath declare that he served in the Revolutionary war as follows, in the 2nd Regiment of the North Carolina Continental line and that he made application for a pension on the 26th day of July 1819 and that he has received a pension Certificate No. 15625 – And I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or otherwise disposed of my property or any part thereof with intent thereby so to

diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed, my property consist of 150 acres of poor land worth \$200 one horse worth \$30 3 sows and pigs worth \$15 farming utensils worth \$5. My family consist of my wife aged 62 years very infirm one son named Alexander aged 41 has been a cripple from dead palsy 25 years as is a great charge -- 2 daughters with small children one son aged 15 years small of his age & sickly, named Hardy -- all of whom are unable to render me any assistance of consequence and my occupation which is that of a farmer at which from age and debility I am very little able to work.

State of Kentucky Caldwell County

On this 13th day of August 1839 personally appeared before Benjamin G. Rice one of the justices of the County Court, in & for the County and state aforesaid Judith Freeman, aged 80 years, a resident of said County, who being first duly sworn according to law, doth, on her oath, make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed July 4th, 1836: That she is the widow of Aaron Freeman who was a private in the 2nd North Carolina Regiment Continental establishment, in the Army of the Revolution, commanded by Archibald Little [sic, Lytle]; that he entered the service under Captain Thomas Armstrong on the first day of August 1781 in Dobbs County, North Carolina, or the term of one year, and was discharged on first August 1782 at Ashley Hill South Carolina; that during his service, he was taken ill & remained a while at Camden in the Hospital, and after his recovery, he did duty as a Sergeant in the guard at Camden. This is in substance but she knows of the service of her husband: nor does she know of any person living who could prove it. One Arthur Brown, I fliving could do so, but she supposes he is dead.

She further declares that she was married to the said Aaron Freeman, on the 9th day of September 1777 in Bertie County North Carolina; that her husband, the said Aaron Freeman, died on the 26th day of November 1821 in Livingston County, Kentucky; and that she has remained a widow ever since that period as will more fully appear by reference to the proof hereunto annexed.

² The War Department read this name as being spelled "Wormarlsdorff." Several places it looks to me more like "Wormarlodorff" or "Wormarlidorff."

[Veteran was pensioned at the rate of \$8 per month commencing July 26, 1819, for service as a private for one year in the North Carolina Continental line. His widow was pensioned at the rate of \$40 per annum for her husband's service for one year in the North Carolina line.]
