Pension application of William Pollard W8862 Elizabeth Goodman f34SC Transcribed by Will Graves 7/24/09: rev'd 12/11/17

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later intereenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

[p 5] State of South Carolina District of Laurens SS

On this 18th day of August in the year of our Lord 1851 personally appeared in open Court before the undersigned Judge of the Court of Ordinary for said District Miss Elizabeth Pollard a resident of the District of Laurens in the State of South Carolina, aged thirty-eight years who being first duly sworn according to law doth on her oath make the following Declaration in order to obtain the benefit of the provision made by the Act of Congress passed July 7th, 1838 entitled "An Act granting half pay and pensions to certain widows;" That she is the daughter and heir at law of Mrs. Elizabeth Goodman deceased who had been first the wife and subsequently the widow of William Pollard deceased who entered the Army of the United States in the War of the Revolution under the following circumstances & served under the following named officers: That said William Pollard deceased during said war entered the militia in the defense of South Carolina and served as a private horseman for a considerable length of time, as this Deponent has been informed & believes, That at the siege of Ninety Six Fort [Siege of Ninety Six, May 21-June 19, 1781] near where he then lived he received a wound in the left breast by which his nipple was torn off -- that after recovering from said wound he again entered the service and continued from time to time in the same until peace was made: That at what time said William Pollard deceased when in the said service or for what length of time in each tour of duty in the militia he engaged, the counties through which he marched or the battles in which he was engaged except the region near and the battles and skirmishes in and about the Ninety Six Fort within a few miles of his house, this deponent at this late day is unable from her recollection of the facts as stated by her said mother & father, to state in detail: of his officers Colonel Robert Anderson was among the number as Colonel and his service under said Colonel Anderson was either under Captain Maxwell² Captain Eliot Moore or Captain Beal. That this deponent has no doubt of the fact of his service under Colonel Robert Anderson: That all of his old Discharges & Army papers have been lost or destroyed so that they cannot now be produced: That said William Pollard after the close of the war living in what is now called Laurens District married said mother of this deponent, viz., Elizabeth White on the 20th day of February in the year 1788 -and that said William Pollard died on the 18th June of 1817. That afterwards to wit on the 5th day of March 1829 said Elizabeth Pollard widow of said William Pollard soldier aforesaid

married Samuel Goodman, who died on the 23rd day of December 1831 which date said Elizabeth Goodman as widow of said Samuel Goodman & also of said William Pollard remained and died such in the District of Laurens in the State aforesaid on the 13th day of November in the year 1850 without ever presenting her claim for any pension from the United States. She further declares that her said mother Elizabeth Goodman deceased was not married to said William Pollard deceased prior to his leaving the service but the marriage took place previous to the first of January 1794, viz. at the time above stated.

Watts gave testimony in Richland district South Carolina that he was the nephew of William Pollard, first husband of the Mrs. Elizabeth Goodman who died at his advanced age in November 1850; that he recalls hearing his uncle relate his services during the services; that he was familiar with his uncle's handwriting and that he has no doubt that the handwriting of his uncle in the records of the Comptroller General is that of his uncle.

South Carolina Laurens District } The undersigned certifies that she was the sister of the late William Pollard Deceased of Laurens District South Carolina -- that they emigrated from Culpeper County State of Virginia with their Father James Pollard preceding the Revolutionary War with Great Britain & that it comes within the knowledge of the undersigned that about the year '87 or '88 the said William Pollard was married to Elizabeth White of the District of Abbeville & State aforesaid that the said William Pollard while engaged in the service of his country was a Dragoon during the Siege of Ninety Six received a wound in his left breast -- his nipple being shot off -- and the undersigned also certifies that she aided in dressing the wound of her brother, he being at that time concealed from the enemy for several weeks & that after his recovery he reentered the service & performed duty until peace was declared. The deponent further states, that her brother the said William Pollard departed this life in June the 18th 1817 -- Subsequently the widow of the said William Pollard married Samuel Goodman & lived with him, one year & 9 months when the said Samuel Goodman died.

State of South Carolina Laurens District: Personally came before me Margaret Watts and upon being examined makes the following declaration in order to enable the heirs at law of William Pollard deceased to obtain a pension &c to wit -- William Pollard was a resident of ninety-six district and living within four miles of the Fort at the time of the siege and that he remained a citizen of the district from that time until his death. Sworn to before me 11th day of April A.D. 1853 & given under my hand and seal of office.
