Pension application of William Jeffries (Jeffris)¹ W9076 Nancy Jeffries f69VA Transcribed by Will Graves 12/18/13

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

And I also declare that I afterwards received certificates for the reward of eighty dollars; to which I was entitled under a resolve of Congress passed the 15th day of May 1778 – And I further declare that I was not on the 15th day of May 1828 on the pension list of the

William Jeffris [sic] of __ in the County of Henry in the State of Kentucky has applied to the Secretary of the Treasury for the benefits of the act, entitled "An act for the relief of certain surviving officers and soldiers of the Revolution," approved the 15th of May, 1828. He states that he enlisted in the Continental line of the Army of the Revolution, for and during the war, and continued until its termination, at which period he was a Private in Captain Watts Company, in the Cavalry regiment of the Virginia line; and that he received a certificate for the reward of eighty dollars, provided by the resolve of the 15th of May, 1778; and further, that he was not on the 15th of May, 1828, on the pension list of the United States, and that he has received as a pensioner since the 3rd of March, 1826, nothing

[p 29: In a document acknowledged December 7th, 1852 in Henry County Kentucky, Nancy Jeffries, 81, gave testimony that she is the widow of William Jeffries, a revolutionary war pensioner whose pension certificate she hereby surrenders; that the deceased pensioner resided in the state of South Carolina about 35 years and then removed to the State of Kentucky about the year 1812 to the County of Henry where he died May 30, 1850. She signed this document with her mark.]

[p. 33: On January 11, 1853 in Trimble County Kentucky, Jesse col gave testimony that he was well acquainted with William Jeffries, a revolutionary war pensioner at the rate of \$100 per annum and with his wife Nancy Jeffries whose name before her marriage was Nancy Connell; and that he the affiant was present at the marriage of William Jeffries to Nancy Connell by a magistrate in Spartanburg district South Carolina in or about the year 1790 to the best of his recollection.

[p 6: On September 7th, 1853 in Henry County Kentucky, Nancy Jeffries, 83, filed for a widow's pension under the 1848 act stating that she is the widow of William Jeffries, a revolutionary war pensioner at the rate of \$100 per annum for his service in the revolution as a Dragoon in the Virginia line; that she was married to him March 4, 1790 by one James Harrison, JP in the state of South Carolina, Spartanburg County; that her husband died in Henry County Kentucky Me 30th. 1850.

[p 35: On March 4th, 1854 in Henry County Kentucky, Susan King, 62, gave testimony that she is the oldest and first child of William and Nancy Jeffries; that a man by the name of Perry wrote the names of her father's family in her father's Bible; that Perry made the mistake of writing her mother's name in the Bible as Elizabeth instead of Nancy; that the affiant was born in the spring of 1791; that her name is the first name on the family register; that she moved about 8 or 10 miles from her mother and father when she married and has never lived further from them than that; that her brothers and sisters are now scattered about in the states of Indiana & Missouri except Mariah the youngest child who now lives with her mother; that her father never had but one wife and that is her mother.

[p 10: On August 18, 1855 in Henry County Kentucky, the widow, 85, filed for her bounty land entitlement as the widow of William Jeffries; she states that she was married to him in Spartanburg district South Carolina by one Isham Harrison a justice of the peace; that her name prior to her marriage was Nancy Connell. She signed this document with her mark.]
