[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of South Carolina District of Charleston:

On this 14th day of October 1842 personally appeared before me Mrs. Mary Mazyck aged 78 years a resident of Charleston South Carolina who being duly sworn according to law, doth on her oath make the following declaration in order to be entitled to the provisions of the act of Congress passed 7 July 1838, entitled "an act granting half pay and pensions to certain widows," That she is the widow of Stephen Mazyck deceased who was an officer in Colonel William Moultrie's 2nd Regiment South Carolina Continental line that he served with said Regiment from nearly the commencement to the end of the war of the revolution, at Haddrell's Point, Sullivan's Island and other places in South Carolina. She further declares that she was married to the said Stephen Mazyck on the 14th day of June 1788, by the Reverend Doctor Hollingshead of the Independent Congregational Church, and that Mr William Mazyck of Charleston was present at said marriage, and that, same is recorded in the handwriting of the father of said Stephen, the part upon which it is so written has been cut out and is herewith put; Deponent saith that, the said Stephen Mazyck died in the month of August 1808, she further declares that she was not married to the said Stephen Mazyck prior to his leaving the service, but the marriage took place previous to the first January 1794, viz., at the time above stated, and that, she has not since married but continues the widow of the above mentioned Stephen Mazyck.



[p 7: William Mazyck, 78, gave a supporting affidavit testifying as to the deponent's belief of the service of the veteran and the fact of the marriage of the veteran to the present claimant. Affiant says he was present at the wedding. His relationship, if any, to the veteran or his widow is not stated.



[Veteran's widow was pensioned at the rate of \$320 per annum based on her husband service as a Lieutenant in the South Carolina Continental line.]
