[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

4th Judicial District of Kentucky

On this 3rd day of November 1818 before me the subscriber one of the Judges of the Circuit Courts for the said district personally appeared John Miles aged 59 years resident in Henry County in said District who being by me first duly sworn according to law doth on his oath make the following declaration in order to obtain the provision made by the late act of Congress entitled an act to provide for certain persons engaged in the land and naval service of the United States in the Revolutionary War that he the said John Miles enlisted in Culpeper County in the State of Virginia on the 15th of January 1777 in the Company commanded by Captain John Gillison of the 10th Virginia Regiment commanded by Colonel Edward Stephens [Edward Stevens] of General Weeding [George Weedon's] Brigade Belonging to the Virginia line and that he continued to serve in the said Corps or in the service of the United States until the month of January 1787 when he was Discharged from the Service in Trenton State of New Jersey by Colonel Samuel Hawes and that he was in the Battles of Monmouth [June 28, 1778] and at the Storming of Stony Point [July 16, 1779] and that he is in reduced circumstances and stands in need of the assistance of his Country for support and that he has no other evidence of his said services than accompanies this.

Noel Judge &c as aforesaid Henry Carter¹ who after being duly sworn states that he was acquainted with John Miles and that he served as a private in Captain John Gillison's Company as stated in his Certificate and that he has known the said Miles ever since and that he is in reduced Circumstances.

[p 9: On May 13, 1839 in Montgomery County Indiana, Polly Miles, 73, formerly a resident of Henry County Kentucky made application for a widow's pension under the 1838 act stating that she is the widow of John Miles a pensioner in Henry County Kentucky for his service in the revolution; that she married him in Culpeper County Virginia January 1, 1784; that her husband died October 9, 1828; and that she remains his widow; that she has no record of her marriage but she has a family record left in the possession of her son John Miles in Henry County Kentucky.]

[p 19: Own April 18, 1839 in Henry County Kentucky, John Miles gave testimony that he is the 4th child of his parents; that he is in possession of the family record in the hand writing of John Greenwood for the first 8 children; the other 3 children's births are in the hand writing of his father John Miles.]

[Facts in file: The widow's name prior to her marriage was Mary (Polly) Duvall; the widow died June 30, 1855; in 1839, the veterans son Jefferson Miles was living in Montgomery County Indiana; Reuben Miles, born July 26, 1765 in 1839 gave testimony while living in Shelby County Kentucky that he was present at the marriage of John Miles and Polly Duvall, the relationship, if any, of Reuben Miles to the family is not stated.]

[Veteran was pensioned at the rate of \$8 per month commencing November 5, 1818, for service as a private for 4 years in the Virginia Continental line. His widow was pensioned at the rate of \$80 per annum.]
